# ORDER OF SUSPENSION

Be it known that on June 4, 2025, the State Commission on Judicial Conduct was presented with a copy of an Indictment handed up on May 27, 2025, by the duly constituted Grand Jury of the 8<sup>th</sup> Judicial District Court, in Cause No. 6729, styled *State of Texas vs. Robert Jenkins Franklin* (the "Indictment," a true and correct copy of which is attached hereto as **Exhibit "A"** and incorporated herein for all relevant purposes).

Having considered the indictment, the Commission concluded that Judge Franklin is charged with two counts of Tampering with a Witness, a Third-Degree Felony and two counts of Official Oppression, a Class A Misdemeanor. The Commission determined that **ROBERT JENKINS FRANKLIN**, should be **SUSPENDED WITHOUT PAY** from the judicial office of Justice of the Peace for Rains County, Texas, pursuant to the authority contained in Article V, Sec. 1-a(6)A of the Texas Constitution and Rule 15(a) of the Texas Procedural Rules for the State Commission on Judicial Conduct, and such suspension remain in effect until the charges set forth in the Indictment are dismissed, Judge Franklin is acquitted of all charges in the Indictment, or upon further order(s) of the Commission.

Accordingly, effective immediately, it is hereby **ORDERED** that **ROBERT JENKINS FRANKLIN** be **SUSPENDED WITHOUT PAY**, from the office of Justice of the Peace for Rains County, Texas. It is FURTHER **ORDERED** that this suspension shall remain in effect until the charges set forth in the indictment are dismissed, Judge Franklin is acquitted of all charges in the indictment, or upon further order(s) of the

Commission. It is **FURTHER ORDERED** that the Commission retains the authority to reconsider this Order should additional information not yet received warrant such action.
